## >> EUROPE: QUEST FOR GROWTH

Major topics to be discussed at the conference will be the experience so far with the ECB's QE program and the interaction with US monetary policy. A significant reason for rising optimism about Europe's future is the pickup of growth this year as well as renewed dynamism for financial markets engendered by the Juncker plan for additional long term investment and the European Commission's plan for a Capital Markets Union.

As a result of these measures, asset managers and financial intermediaries are looking at possible alternatives to classic fixed income instruments for long term financing in areas such as infrastructure, using a combination of public funding (channeled through the EIB and other official agencies) and private money.

The conference aims to give delegates a platform for an exchange of views and discussion of best practices regarding these and other SSA related topics.


